VI. MATSOGI | SPARRING

Protectors and equipment

Each individual coach is fully responsible for his competitor. He will assure for all his competitors to use protection gear according to I.T.F. rules.

- juniors and adults female have mandatory chest protector
- protectors of hands, feet and head DON'T HAVE to be red or blue color
- helmet (head protector) is mandatory for children, pre-juniors and juniors
- teeth protection and jockstrap are mandatory for all categories
- Open gloves for all categories
- **NO BOX GLOVES, NO BANDAGES/WRAPS, NO KARATE GLOVES**

VII. COMPETITION SYSTEM

The competition system will be each against each other (league) when there are 3 competitors in one category. Otherwise there will be single elimination.

In groups, competitors compete only in optional pattern and sparring 1 x 2 minutes (or 1,5 minutes).

In the finals there is 1 optional + 1 designated pattern sparring 2 x 2 minutes (or 1,5 min).

A group match can end in a draw and each competitor will record 1 point in the table.

2 points for victory.

X. RULES

The rules of I.T.F. of Choi Jung Hwa Organization will be valid in this competition.

IX. PROTEST / OBJECTION

Protest/Objection against umpire award during the competition can be announced and handed over to umpire chairman only by coach in written in conformity with the procedure (within 5 min. after the end of fight) together with advance payment of **1.000 CZK / 40 EUR**, the advance payment will be handed over directly to Umpire chairman.

Subsequently, the protest will be discussed and resolved by the Committee of Referees (CoR). The CoR's decision is final.

VIII. REVERS

Each competitor is obliged to hand over filled declaration and consent about the competition at the registration. For all competitors who will not be 18 years old, the declaration and consent has to be signed by legal representative.

Without valid revers, participation on the competition will not be permitted.

XI. UMPIRES

The maximum number of referees for this event is 30. The committee of referees will have one member.

Each club must provide at least 1 umpire, otherwise the event committee has the right to charge 50,00 EUR | 1 250,00 CZK per missing umpire.

Each umpire must be present at the registration together with his club.

Each umpire who officiates does not pay an entry fee.

Meal – catering will be provided for the referees.

Duties of referees - Referees are required to be dressed according to the ITF Rules (black trousers and white long-sleeved shirt or blouse with tie) and to be present on the competition area of the hall during the competition day according to the instructions of the Head referee and to be competent to make decisions.

XII. COACHES

Each competitor, who starts in the sparring category, must be accompanied by a **coach older than 18 years** and dressed according to the rules of I.T.F (training clothes/tracksuit and training shoes - NO DOBOK) .

XIII. TROPHIES

Medals will be awarded for 1st, 2nd and 2 x 3rd place in each category.

Trophies will also be presented to the most successful individuals (children m/f, pre-junior m/f, junior m/f, adult m/f) and also to the three most successful subjects.

Change in the start list

Any change in the start list (e.g. in connection with the incorrect inclusion of a competitor in a category, etc.) after consultation with the coaches will be made for a fee of 1 000 CZK / 40 EUR.

The key to determining the most successful competitor and subject

It decides the total number of points for the medals won- gold (3 points), silver (2 points), bronze (1 point). In case of equality of points, the weight of the discipline decides- descending tul-matsogi. In case of the same weight of the disciplines, the number of competitors in the category will decide.
